Ethereum Adoption

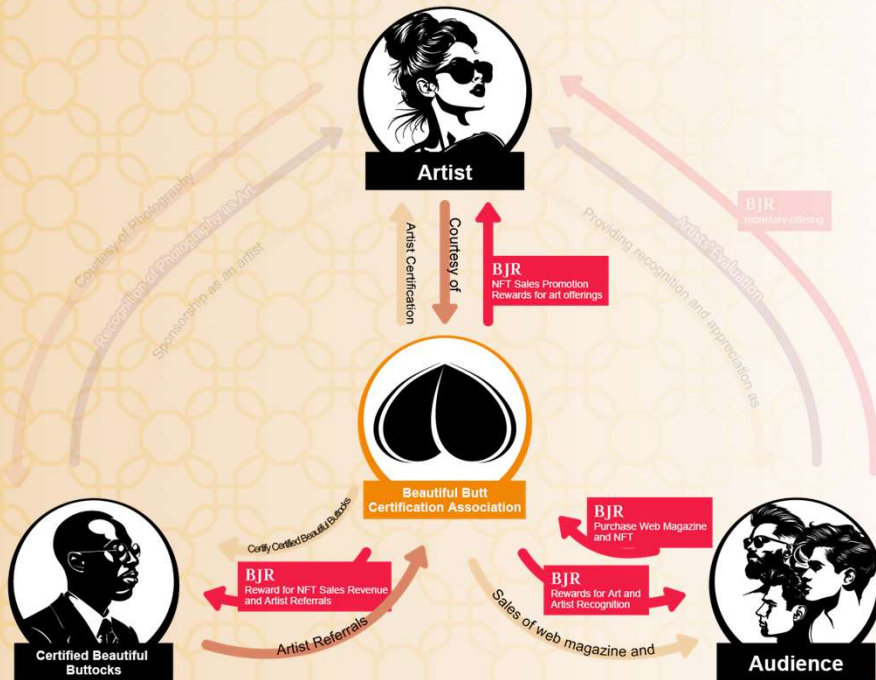

Beautiful Buttocks Certification Association (The one and only certification body creating new value and a future for art)

The general incorporated association "Bijiri Certification Association" is the only organization in the world that certifies Bijiri art, the artists who provide it, and the Bijiri certifiers who evaluate both.

The purpose of the certification association is the "training of Bijiri certifiers and artists" as well as the "promotion and publicity of art," including community management and event organization.

To achieve this, the certification association has the following six functions.

- Issuance of BJR tokens
- Issuance of Bijiri art NFTs
- Certification of Bijiri certifiers
- Evaluation and certification of Bijiri art
- Community management
- Organization of events

Certified Beautiful Buttocks (An evangelist of innovative Bijiri art)

The position of Bijiri Certified Artist plays an important role in promoting the beauty and value of Bijiri art. This position identifies talented artists and their work and recommends them to the association. By gaining recognition from the association, artists and the art of Bijiri are able to increase their value.

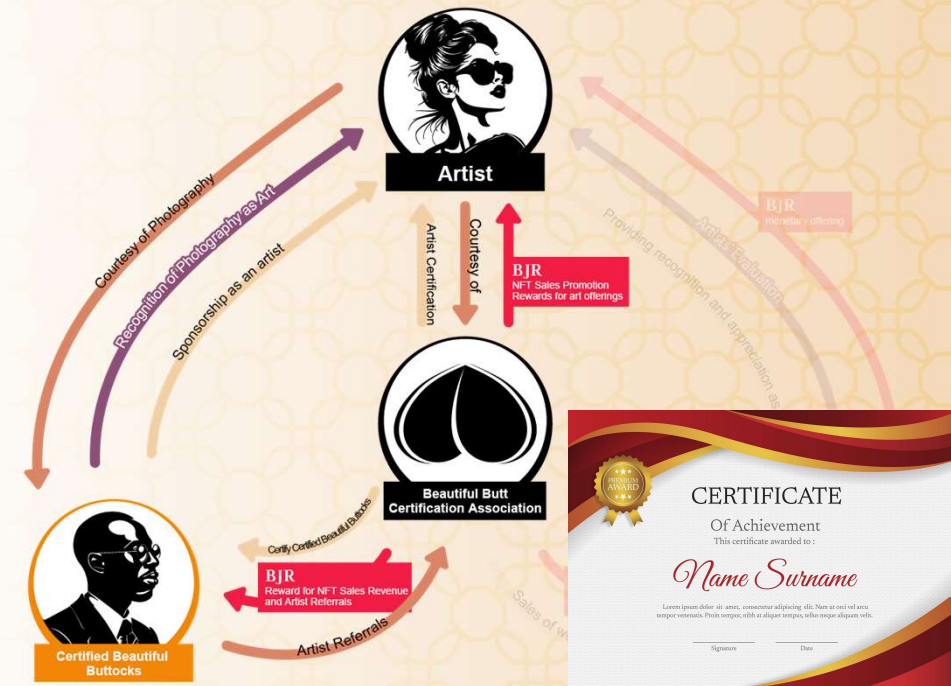
Registration for this position can be done either by paying a registration fee or by referring a predetermined number of artists. There is no registration fee, especially for the Bronze rank, but you must refer one artist.

There are four ranks for this position based on contribution. The ranks are Bronze, Silver, Gold, and Platinum. Criteria for recognition of ranks include the number of artists recommended to and recognized by the association, the amount of Bijiri art NFTs distributed through recommendations to and recognition by the association, and other contributions made to the association. In addition, ranks can be raised by paying the stipulated registration fee.

By working as a Bijiri Certified Artist, you can dramatically increase your influence on Bijiri art and the economic sphere surrounding it. Through endorsement of artists and their work, you can not only enhance your own reputation, but also contribute to the growth of the certification association. The Bronze rank in particular is free of charge, making it easy for newcomers to take on the challenge.

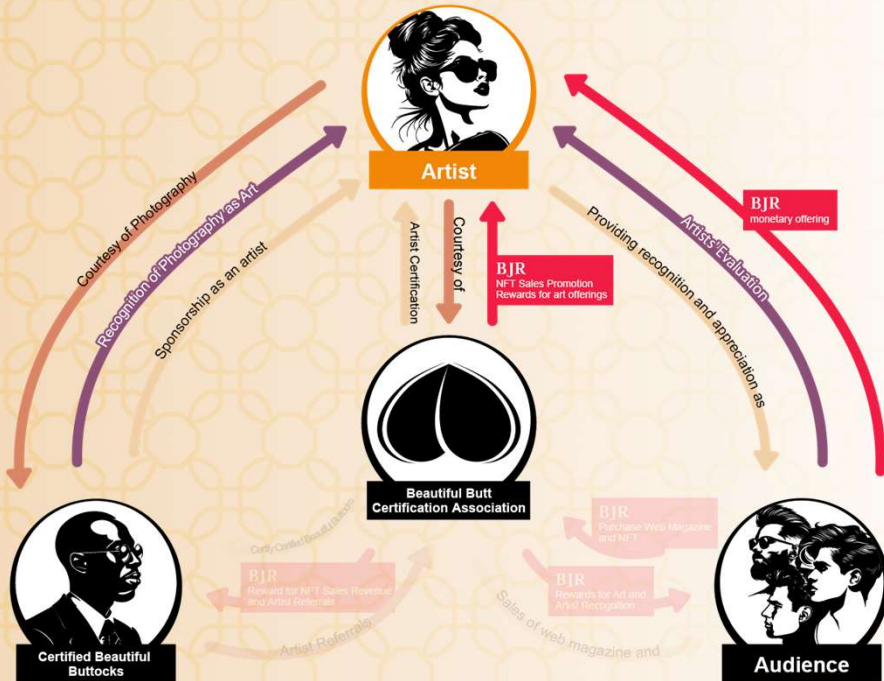

Helping Communities Grow

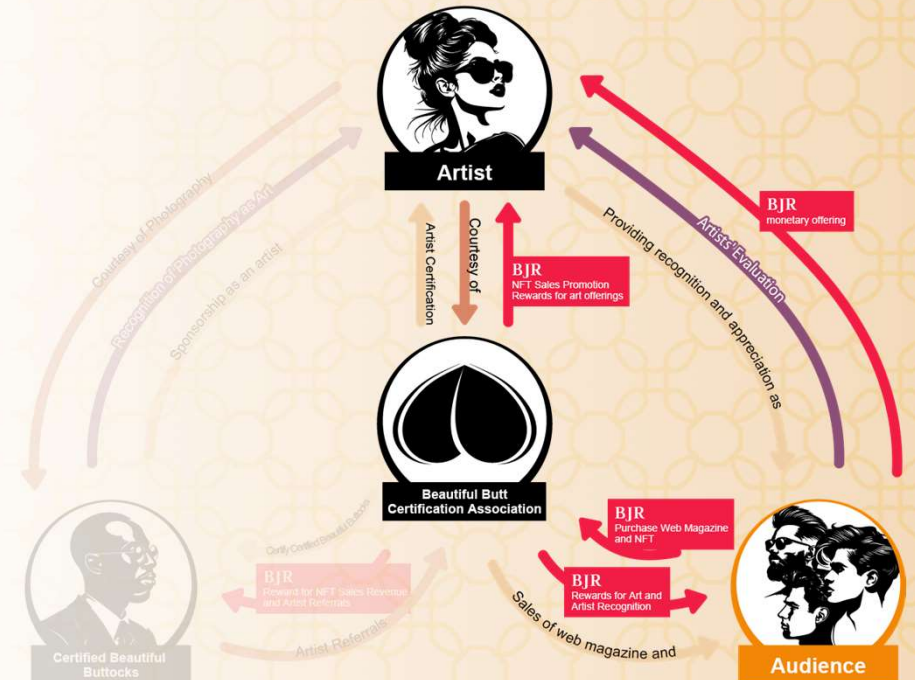

Contribute to the development of the economic zone

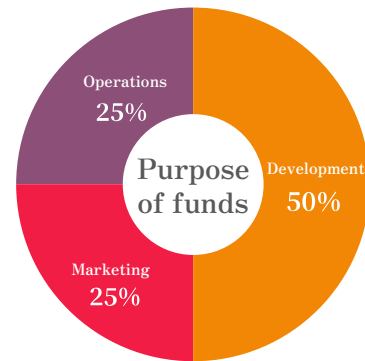
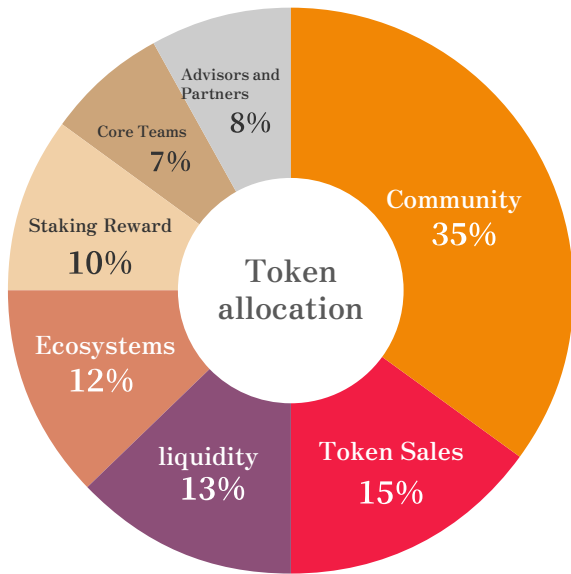

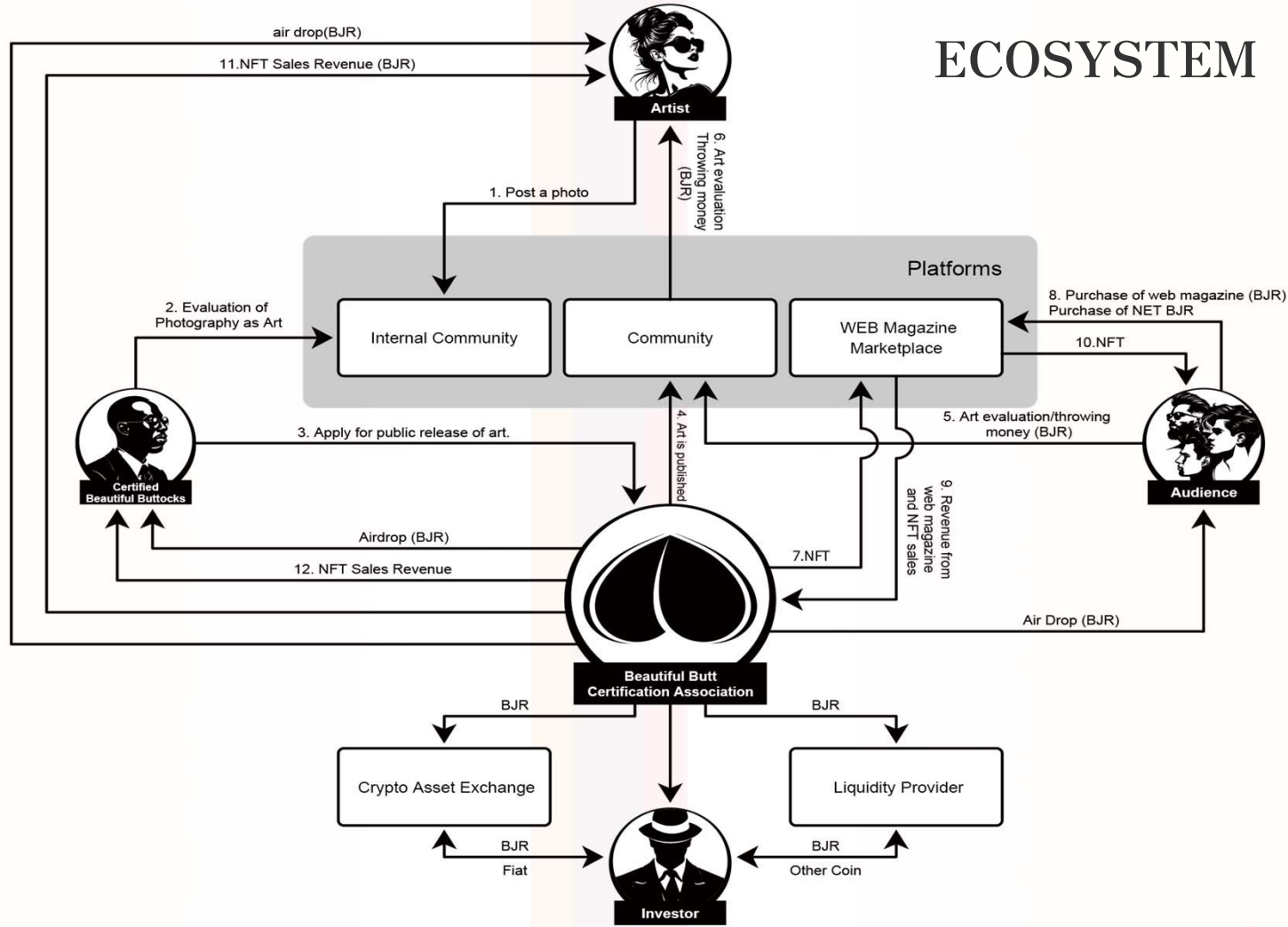
TOKEN ECONOMY



A total of 3.4 billion BJR tokens have been issued, and they are planned to be allocated as outlined below. No more than 3.4 billion tokens will be issued, but the total supply may decrease if any issued tokens are burned.

Community	35%	It will be used for community activities that are central to the project. (i.e., support for various activities of the artists and rewards for contributions to the community of certified beauty buttocks and audiences)
Token Sales	15%	We sell to investors through the market.
liquidity	13%	It is used for the purpose of providing liquidity and maintaining the soundness of liquidity.
Ecosystems	12%	We plan to use it for the permanent maintenance and expansion of the ecosystem.
Staking Reward	10%	We plan to use the BJR token as a reward for the staking feature to maintain the price of the token.
Core Teams	7%	It will be used as an incentive to the team responsible for operations and development. It will also be used to attract future team members.
Advisors and Partners	8%	The allocations will be allocated to organizations and individuals who will collaborate externally to develop and maintain the ecosystem, as well as to partners who will work with the project.

The funds obtained through the token sale will be used for the development of the community's platform and smartphone application, initial promotion and other marketing expenses, and peration expenses.



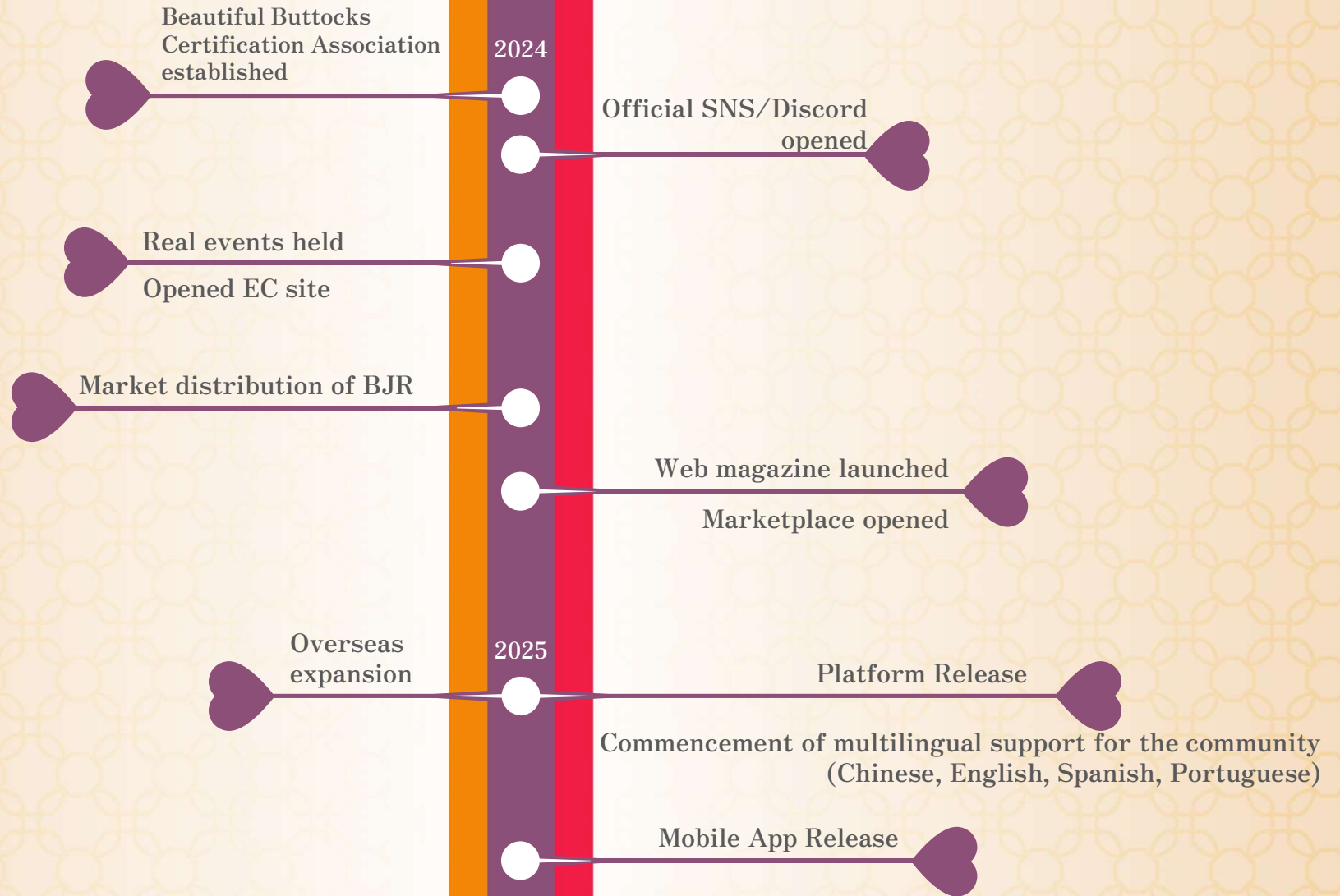
ECOSYSTEM

The entire ecosystem of the project, as shown in the correlation diagram, centers on the Bijiri Certification Association and Bijiri Certifiers monetizing the activities of artists through the platform by using BJR tokens.

Additionally, the Bijiri Certification Association will ensure the price and liquidity of BJR tokens, as well as share BJR tokens to maintain the ecosystem.

1. Artists post photos to the platform
2. Certified Beautiful Buttocks evaluates photography as an art form.
3. Beauty Butt Certification holder applies to the Beauty Butt Certification Association for publication of the art.
4. Beautiful Butt Certification Association publishes the art on the platform after the examination.
5. Audience appreciates and throws money to the public art.
6. Artists receive recognition and throw money for their art.
7. The Beautiful Buttocks Certification Association introduces highly regarded art in its web magazine and sells it as NFT.
8. Audience subscribes to the web magazine and buys NFTs they like
9. The Beautiful Buttocks Certification Association will receive revenue from the sale of the web magazine and NFT.
10. Audience gets NFT
11. Artists receive a share of the proceeds from NFT sales
12. Certified Beauty Butt receives a share of the proceeds from the sale of NFTs.
